Annual Meeting Agenda: The annual meeting will be held Saturday, June 28, 2014, at Evergreen Resort with registration and visiting beginning at 10:00 and the meeting starting at 10:30. Following the meeting there will be a picnic lunch catered by The Good Life Café. Discussion was held regarding the agenda for the meeting. The idea is to divide the lake into quadrants, or smaller sections, and to train volunteers to inspect the lake in those sections. Data would be collected and submitted to a statewide website.

**Public Access Bulletin Board:** Carol Zimmerman continues to take care of the public access bulletin board.

**COLA Meeting:** Big Sand is one of the lakes scheduled to serve refreshments at the next COLA meeting. Candy and Irene will bring treats.
