The days are longer, and the temps keep rising. Spring is just around the corner, or have we already hit the corner? It has been a crazy winter without the snow and cold that we are accustomed to experiencing. Our lake levels were down last fall and the hope that a normal snowfall would bring the lake levels back up is not promised. Hopefully we will have spring rains to help the cause. It's become a challenge to keep adding to the dock in order to get the boats on lifts.

Your Big Sand board has been hard at work on a number of issues, and I want to thank them


for their time and efforts. Their dedication to preserving our lake and bringing our residents together to create a more inviting community to gather and enjoy is immeasurable.

At the end of 2023 the lake membership stood at 156. The goal for 2024 is to have 100% of the lake residents become members. The first step towards that goal is to make any NEW Big Sand Lake residents honorary first year members. In other words, the first-year membership is free. Jo Kilander has been working on dividing the lake into neighborhood sections with section captains entrusted with the task of calling on those who are new to the lake as well as calling on those who are not members. Invasive species are always on the mind of lake residents. Our charitable foundation pays for our share of monitoring the landing and checking boats and trailers for invasive species. We have contracted for 1100 hours of work from the DNR at \$25 per hour. So far, our investment has been successful, but we need to be vigilant and continue this work. Your donations to our charitable foundation are greatly appreciated and help ensure that we can continue the fight against AIS. At the end of summer 2023 board member Catherine Williamson was involved in the hiring of Steve Henry, an aquatic survey professional, who did a complete aquatic plant survey and an invasive species detection of Big Sand. I'm pleased to say that we passed with flying colors. A copy of that report is available to members. 

IT'S TIME FOR MEMBERSHIP DUES RENEWAL AND CHARITABLE

FUND DONATIONS FOR WATERCRAFT INSPECTIONS

The Big Sand Lake Association (BSLA) and the Big Sand Lake Charitable Fund Advisory Committee have been brainstorming over the winter how best to clarify for BSLA members the difference between the finances and fundraising of the two entities. We continue to hear that it is confusing how financial contributions are used, and members forget what they paid for and when they paid it! Therefore, it was decided by the BSLA board that fundraising for the two separate bodies would be combined into an annual spring campaign appeal.

WHAT DOES THE BIG SAND LAKE ASSOCIATION DO?

The Big Sand Lake Association conducts many important activities to "promote and maintain the environmental, economic, and recreational protection of Big Sand Lake," and to make it a safe and wonderful place to own a home or cabin. BSLA maintains the bigsandlake.org website, distributes newsletters, maintains a member directory, conducts lake water testing, applies for grants to help offset the cost of DNR watercraft inspection at the boat launch, maintains webcams, coordinates social events and so much more.

Annual dues to pay for the activities of the BSLA are set at \$50 for members/property owners, and Associate Member dues are \$20 per year for family, friends, and non-property owners. Think of BSLA money as our household checking account, taking care of smaller day-to-day expenses.


WHAT DOES THE BIG SAND LAKE CHARITABLE FUND DO?


The Big Sand Lake Charitable Fund was established in 2009 to "preserve, protect and enhance Big Sand Lake and its environs." The Big Sand Lake Charitable Fund is managed by the Northwest Minnesota Foundation. Examples of how the fund has been used include helping to pay for the costs of the annual DNR watercraft inspections, and for the special aquatic survey conducted this past year. In addition, the fund is available to support other large expenses or special projects necessary to

protect the lake, including quickly addressing any possible AIS infestation emergencies. <u>Think of the Big Sand Lake Charitable Fund as our long-term savings account.</u>

One of the main priorities of the Big Sand Lake Charitable Fund has been to raise money each year to pay for the cost of DNR boat inspectors stationed at the Big Sand Lake boat launch to prevent the spread of aquatic invasive species into the lake. For 2024, there will be 1,100 inspector hours contracted with the Department of Natural Resources (DNR). After grants received from the state of Minnesota and Lake Emma Township, the balance of the DNR watercraft inspection bill is \$15,200, and we are once again seeking donations to cover the expense. Therefore, in addition to paying your annual membership dues, please donate to the Big Sand Lake Charitable Fund to help cover the cost of this critical activity that is our best weapon against the spread of aquatic invasive species.




MEMBERSHIP DUES Continued


