



PRESIDENT'S LETTER

Halloween is behind us (or maybe in front of me because of all the unneeded calories that I've snatched from the "Trick or Treat" basket) and we are beginning to prepare for the Thanksgiving holiday. Even with our continuing battle with COVID, we have a lot for which to be thankful.

The past year on Big Sand saw continued excellent water quality. A big thank you to the testing team led by Richard Provinzino. Because of the generous contributions by you, the BSLA members, we were able to test and monitor for invasive species and keep them at bay at least for now. Invasive species seem to be creeping closer and closer. Thankfully, through cooperative funding by Lake Emma Township, Hubbard County, and our Charitable Lake Fund, we had significant hours of inspection at the public access this season.

The work on the reimagined public access has been another intrusion on Big Sand Lake life. As hard as many lake residents tried, we were not able to stop the DNR project. I'm still hopeful that once it is complete it will be an improvement even though the general feeling remains that it was not necessary.



Our neighbors on Gladwin Drive have dealt with the brunt of the disruptions, so I'm hopeful that the remaining work next spring will go smoothly. I happened to catch the job superintendent on the day the ramp was reopened the first week in October and pushed him pretty hard on his spring schedule for putting down the two layers of asphalt and remaining landscaping. He



shared that since all the grading is already done that it will be one of their first projects after road restrictions are removed. Fingers crossed that it will be finished for our May fishing opener weekend!

We were a little nervous about only using email and our website to notify residents about our Annual Meeting in June. Our fears were unjustified as the resulting turnout was beyond expectations. Based on the size of the crowd, the BSLA Board will try to streamline the registration process and start it earlier to allow for plenty of time to socialize before the start of the business meeting.



In the midst of continued COVID restrictions and precautions, we were still able to enjoy a well-attended social on the Corwin properties on a beautiful summer evening in July – thank you Betty, Wick, Holly, Carolyn and Dick Brammell! BIG SAND LAKE 2021 WATER REPORT

For further information and historical data about BSLA, google 'DNR-MN Lake Finder' and follow the prompts to Big Sand Lake Hubbard County.

Big Sand continues to be one of the most clear and healthy lakes in Minnesota. Secchi disc readings this year ranged from 34-17 feet; temperature/dissolved oxygen readings, and the phosphorus and algae reports are holding at previous levels. The good news is that the zebra mussel veliger testing was clear. Gene Fladeboe reports that the lake dropped .94 feet at the low and came back to .62 feet lower than the Spring baseline.

Thank you to the following volunteers: Richard Provinzino and Gene Fladeboe for doing the secchi disc readings; Bob Bray for the zebra mussel veliger testing; Gene and Julie Fladeboe for the Phosphorus and Algae sampling and sending that to the lab in Detroit Lakes; and Randy Seaver and Gene Fladeboe for taking the temperature and oxygen readings.

2021 AIS INSPECTIONS SUMMARY



Richard Provinzino submitted these photos taken this October by a relative on Big Birch Lake in Melrose County of his zebra mussel encrusted lake equipment. Zebra Mussels were first discovered there in 2016. Within two years the whole lake was infested.



Nick Macklem, Hubbard County Environmental Specialist, and head of the AIS Inspections program, provided the following summary information.

Certified AIS inspectors were on duty at the Big Sand access for 972 of the hours of the contracted 1,100 hours during the 2021 boating season. The 128 hours of inspector time lost when the access was closed during construction will be credited to Big Sand for the 2022 season.

A total of 1,504 inspections were conducted – 892 were for watercraft entering Big Sand and 612 exiting. 115 were from out of state; 133 were entering from infested waters; 86 were from Zebra Mussel infested waters; 11 from Starry Stonewart infested waters; 8 had plugs in on arrival; and 2 had plants, animals or mud found upon arrival.

A BIG SAND STORY

Hello and Good-Bye

Cynthia and Ellis Jones said hello to Big Sand in June 1995 when they purchased their home on County 40 on the north shore of the lake. The house, one of the newer structures on Big Sand, was built in 1989 by John Masog, a Park Rapids attorney, now deceased.

How the Joneses became Big Sanders begins like this. Ellis was a pilot for Northwest Airlines. He and Cynthia were living in Kansas City when Ellis's assignment with Northwest became Anchorage, Alaska. They were going to relocate to Minneapolis for convenience for Ellis's job. Instead, they decided on Park Rapids, arriving in November 1994. Family connections and the lure of lake country were the incentives for this decision.

Ellis spent many summers here with his parents. His father had been coming to the Park Rapids area from Kansas City for summer-long visits since childhood. Ellis's mother grew up in Park Rapids and met Ellis's father at age 16 so connection to Park Rapids was strong. Cynthia and Ellis lived in Ellis's father's cabin on Fishhook Lake from November 1994 to June 1995 when they purchased the property on Big Sand.

Cynthia immediately jumped into being active with the lake association. She was part of the group responsible for rejuvenating BSLA when the membership had dropped to a low 32. Cynthia wrote the newsletter for several years which at that time was called the Sandpiper. Cynthia also served as BSLA treasurer for 16 years, retiring from that position in 2013. Ellis also served on the BSLA Board of Directors from 2014-2019.

From May 2001 to May of 2019, Cynthia owned and operated her beautiful store, Riverbend, on main street in Park Rapids. She sold to Lyle's Shoes of Wadena now in Riverbend's location. Both Cynthia and Ellis were pillars of the downtown business community helping to make Park Rapids the vibrant community we all enjoy.

Now Cynthia and Ellis are saying good-bye to Big Sand and Park Rapids as they are moving to Colorado to be closer to family and grandchildren. They sold their home on October 15 to Kyle and Patricia Rasmussen who are starting their own Big Sand story. Kyle is a retired hospital administrator and Patricia is a family physician at Essentia Health in Park Rapids. We welcome them to the Big Sand neighborhood.

ALMOST NORMAL

It is hard to beat a summer on Big Sand Lake... but readers of this newsletter already know that, don't we? This year, the summertime seemed especially sweet, after 2020's lockdowns and pandemic fears. Covid regulations were at least partially lifted, thanks to vaccine availability and the care taken with social distancing, and life began to feel more normal here on the Lake.

As always in the North, the transition from spring to summer happens in a rush, typically in June. This year was no different, though, as with most of the rest of the country, this summer proved to be hotter and drier than any on record. We missed our usual dose of regular thunderstorms throughout the season. The lake level went down by a foot and the grass in the ditches began to look pretty dry. There was even a large, persistent wildfire in the northeast part of the state, along with smaller blazes elsewhere. Smoke from fires in Canada (which are not suppressed in that country) blew south and made it difficult to even see across the bay for much of July and into August. Tourists returned to the Lake Country, and businesses in town reopened to do their usual trade. We happily participated in the annual Boat Parade on Big Sand Lake on a breezy July 4th. The flowers in my boxes bloomed like crazy. The swimming and boating was superb. Neighbors sunning on their docks never failed to wave as we boated by along the shoreline. Friends and family came for visits and enjoyed a share of lake time. All-in-all, it was summertime, and the livin' was easy.

It is now fully fall here on Big Sand. Summer's extra heat has proven to confuse the color in the trees this year, with various species peaking in different sequence than normal, but gorgeous nonetheless. The weather has been warm and pleasant, and the woods in their glory. We got our final boat rides in and the docks and lifts removed before the weather begins to turn cold and the snow flies. For now, the final leaves cling to the trees and the lake is largely empty of boats, but lambent in the fall sunlight. For us, autumn has become the sweetest of all seasons, a time to be savored before the harsh but beautiful cold of winter, the cycle of life.

She loved Big Sand sunrises, long pontoon rides, and usually was the last to leave the campfire. She started the day by walking or swimming, and then would make time in the afternoon to get back outside and cross-country ski. Candy’s friends knew that she was always planning their next adventure or looking for a book to recommend for book club. She was an active community member and taught us all the importance of showing up for others. Above everything else, Candy was a loving sister, mom, and grandma.”

Candy is survived by 3 children – Dona (Mark) Mulrooney, Blaine, MN; Jason Malm, Liberty, MO; Sam (Sheena) Malm, Dresser, MN; and 7 grandchildren who continue to be frequent Big Sand visitors.
