



PRESIDENT'S LETTER

I'm hoping you are all having an enjoyable spring (if that's what you call it!)? I was fortunate enough to be at our Big Sand cottage on the night of the lunar eclipse. Amazingly, I was able to stay awake to witness the eclipse in person and not have to rely on the television replay. One more unforgettable memory from Big Sand!

As previously sent out in an email blast, our "Ice Out" Contest finally came to a conclusion on May 9th at 9:30am. The prized trophy went back to a familiar location, but with a new winner. Congratulations, Pam Kobriger! Thanks to the dozens of you who entered a guess!

The saga of the "new and improved" boat ramp continues. In talking with Dave Schotzko with the DNR, he indicated that the bituminous plant which provides the servicing materials was late in opening because of the late spring which has caused more delays. The DNR has now given the contractor the dates of June 1-15 as a window for completion. The actual work should only take 2-4 days during that window. Hopefully, you will all have your docks in and boats on lifts before June 1!

Water quality and zebra mussel testing will continue this summer, as well as our AIS inspections at the boat ramp. Be sure to read the Water Quality article elsewhere in this newsletter. Our wish is to keep our Big Sand Lake as beautiful and pristine as we've become accustomed to expecting.

LET'S ALL ENJOY BIG SAND AND DO OUR BEST TO PROTECT OUR SHORELAND

We are a multipurpose lake – swimming, fishing, canoeing, kayaking, pontooning, jet skiing, tubing, water skiing and wake surfing. (Did we miss anything?) Fortunately, there usually is room on the lake for everyone. However, please always be aware and courteous of others. Also, please consider Big Sand's shoreline and the erosion that large waves can do. Tubing, jet skiing and wake surfing should be kept well in the middle of the lake. Please use slow - no wake speed within 150 feet (or more) of the shore. Let's keep Big Sand the beautiful place it is now and for future generations.



BIG SAND LAKE WATER CLARITY

For further information and historical data about BSLA, google 'DNR-MN Lake Finder' and follow the prompts to Big Sand Lake Hubbard County.

Water clarity on Big Sand Lake continues to be exceptional as the Secchi Disc readings ranged between 25' to 36' last year. The Secchi Disc readings are sampled at 5 different sites during the summer and sent to the MPCA for yearly data review.

The readings on Big Sand Lake go back to the mid 80s and have improved dramatically over the 35+ years. The likely reason for this improvement is that the newly formed Big Sand Lake Association arranged for a fly over of Big Sand in 1988. This action resulted in Big Sand Lake becoming the first in Hubbard County to have 100% of its septic systems upgraded and compliant with county standards.

Besides monitoring water clarity, BSLA volunteers conduct other monitoring and testing activities. Water quality (Phosphorus and Chlorophyll) is monitored monthly May-September; testing for the presence of zebra mussel larvae is done twice each summer; and measurement is done for the dissolved oxygen levels (conditions indicating healthy environment for tulibee, a food source for walleye and other large fish). Thank you to the current BSLA volunteers who get out on the lake and perform these important tasks. Gene Fladeboe and Randy Seaver are doing the sampling for water quality and dissolved oxygen levels, Bob Bray is doing the Zebra Mussel veliger sampling, and Gene and Rich Provinzino are doing the Secchi Disc readings for the MPCA. WILDFLOWER TREASURES

Terry Klepinski sent the following information about wildflowers that can be found in the woods around Big Sand and perhaps in your own backyard. Terry is a Certified Master Naturalist Volunteer and facilitator of the Wildlife and Environment section of Big Sand Lake's Management Plan.

In addition, look for Columbine in a backyard near you or even your own! The early leaves may look like a weed but don't pull! You will be rewarded with delicate red with yellow flowers delicately hanging upside down from long, slender stems.

If you are interested in learning more about wildflowers and how to look for them, a good resource is Searching for Minnesota's Native Wildflowers – A Guide for Beginners, Botanists, and Everyone in Between by Phyllis Root.

RED COLUMBINE / AQUILEGIA CANADENSIS

Plants reach 1-3 feet tall. Leaves are alternate and compound with rounded leaflets up to 3 inches long and wide. Flowers are made up of 5 yellow petals surrounded by 5 red petal-like sepals which are 1-2 inches long and hang downward.



MERRYBELLS / UVULARIA GRANDIFLORA

Native Minnesota perennial with twisted yellow flower 1" - 2" long, in shade or part shade. Grows 1-2 feet tall and blooms from April through June. Green leaves surround the main stem.



BLOODROOT / SANGUINARIA CANADENSIS

Native Minnesota perennial, grows in part shade or shady woods. Small white flowers bloom for one or two days. Blooms from March through May, is 6-12" tall can emerge while snow is still on the ground. Named for the red juice that bleeds from the broken stems, leaves and roots.



HEPATICA / ANEMONE ACUTILOBA

Sharp lobed Hepatica, a perennial native Minnesota wildflower. Flower is 1/2 inch wide, usually violet to white in color but can be multicolor as shown; plant is 6" tall. Leaves open after flowers bloom. Hepatica is among the first Minnesota wildflower to appear in the spring. Leaves are egg shaped with pointed tips.

EDUCATIONAL COMMITTEE

Help plan educational workshops for BSLA members

Examples: Identification and mapping of lake vegetation; installing rain gardens and buffer zones, etc.

UNDERSTANDING THE BIG SAND LAKE CHARITABLE FUND

In 2009, with a common interest and vision for protecting and preserving beautiful Big Sand Lake, the Big Sand Lake Association (BSLA) established the Big Sand Lake Charitable Fund (BSLCF), with the Northwest Minnesota Foundation. At that time, lake association members and their families and friends made donations to seed the fund.

The stated legal purpose of the fund was to “provide financial support to protect, preserve, restore and enhance the quality of Big Sand Lake and its environs.” The agreement that governs the use of the fund also includes other terms and restriction including that the fund can support an area that includes “Big Sand Lake and the land within 1,000 feet of Big Sand Lake.”

The agreement also states that the BSLCF must be managed by a Fund Advisory Committee of no less than three, and no more than five members, who are responsible for “determining the use of earnings and/or assets of the fund are used in a manner consistent with the stated purpose of the fund.” Current Fund Advisory Committee members are Chris Hilger, Ann Hilger and Linda Lee.


When the BSLA needs money from the BSLCF, they complete a formal grant request with the Northwest Minnesota Foundation, and submit it to the Fund Advisory Committee. It is then the responsibility of the Fund Advisory Committee to recommend approval of the grant to the Northwest Minnesota Foundation. Ultimately, however, the NWMF has final approval discretion. To date, the BSLCF has only been asked to recommend funding of watercraft inspection at the lake public access, but could also be asked to recommend funding for other purposes in keeping with the stated mission.

Each year, the Fund Advisory Committee runs a spring campaign to raise money to cover the cost of DNR watercraft inspection, so as not to deplete the BSLCF. Ideally, the BSLCF will grow in order to stand ready to deal with any potential future need, such as a remediation treatment in the case of an AIS infestation.

In recent years, donations to the BSLCF for the spring campaign have been sufficient to pay the watercraft inspection bill, and sometimes even slightly exceeded it. The BSLCF is slowly growing, and the current total balance is \$166,530.07. Donations to the fund are welcome and encouraged throughout the year!

When the Big Sand Lake Association solicits annual dues and donations each January, those funds do not go to the BSLCF. Only donations made directly to BSLCF of the Northwest Minnesota Foundation are a part of the BSLCF. Donations to BSLCF are tax-deductible.
